### What Is the Training?

Every three years, pastors and elders within the bounds of Glacier and Yellowstone Presbyteries are required to complete an ethical and boundary training event. This workshop will provide the mandatory ethical and boundary training to address issues of behavior, healthy decision-making and risk management in terms of ministry leaders/workers in the church. Based on a biblical theological foundation, we will learn the importance of healthy boundaries, information on current Montana law regarding mandated reporting, discuss boundary challenges with internet technology and consider the importance of self-care and peer support.
